A. CALL TO ORDER

The Regular Board Meeting of the Delta Farms Water Control District ("District") of August 23, 2022, was called to order at 8:04 a.m. in the offices of Carter Associates located at 1708 12st Street, Vero Beach, Florida 32960.

B. PROOF OF PUBLICATION

Proof of publication was presented that showed notice of the Regular Board Meeting had been published in the *Indian River Press Journal* on August 10, 2022, as legally required.

C. ESTABLISH A QUORUM

Mr. Sakuma stated that the attendance of Supervisors Clayton Amestoy, Tim Dooley and Wilton "Rusty" Banack constituted a quorum and it was in order for the meeting to proceed.

Also in attendance were: District Manager Frank Sakuma of Special District Services, Inc. and District Engineer Tyler Spencer P.E. of Carter Associates.

D. ADDITIONS OR DELETIONS TO AGENDA

Mr. Banack confirmed the Treasurer's Report would be included in the meeting. No other additions or deletions were offered.

Re: Pump Repair- Remove, Repair and Reinstall (1) Couch 30" x 15,000 GPM Gear Drive Pump

Location- The west pump from the Premium Farm pump station.

We found the pump seized up where it would not rotate. When the pump was pulled from the sump, we could see that the stainless-steel bowl liner had torn free and wedged itself between the propeller blade and the bowl housing. The liner was bent and possibly so were other components. This abrupt stop while under power can affect other power train components such as the right-angle gear drive and the shaft, this condition always warrants further inspection.

Our scope of work and supply is as follows:

1. Disconnect and transport pump to shop.

(2) Field mechanics 6 Hrs. each @ \$110.00 per/Hr. each \$1,320.00 23 Ton crane truck 4 Hrs. @ \$100.00 per/Hr. \$400.00

Total \$1,720.00

- 2. Pump Repair-
- a) Disassemble pump and evaluate necessary repairs.
- b) De'ran right angle gear drive- Inspect and reuse. Drain lubricant, remove pinion housing, inspect gears and bearings. No visible damage was found, and the oil had no large metal particle. We are recommending replacing the pinion gasket and replace the fluid with new.
- c) Shaft- Build up lower bowl bushing and seal area, machine and straighten to tolerance.
- d) Shaft Tube- Clean, air test and reuse.
- e) Bushings- Replace lower bowl bushing.
- f) Seals- Replace all seals.
- g) Propeller- Re-blade, machine, and balance. Note: The existing blades are worn thin.

- h) Propeller Shroud Liner- Replace stainless steel liner. Note: cavitation and turbulence eroded the materials around the liner weld enabling it to break free.
- i) Intake Bell- Replace the intake bell transition cone, the existing guide vanes cone have been replaced we will reweld this component into the new bell. The existing intake bell transition has worn thin and has areas with deep cavitation damage. The guide vanes are welded to this casing component. If there were to be excessive vibration from cavitation or other hydraulic forces the guide vanes could tear free from this thin bell casing and get jammed into the propeller. This lower area of the bowl experiences intermittent cavitation over time from aquatics accumulations blocking the flow of water. Over the years we have removed large accumulations of aquatics blocking the station.
- j) Casing- Grind and weld cracks and wear in bowl area.
- k) Re-assembly- Reassemble pump complete re-installing all the new and refurbished components in place and operational. Fill pump with lubricants.
- I) Hardware and Gaskets- Replace all hardware and gaskets.
- m) Coatings- brush blast this existing epoxy coating and recoat the interior and exterior.
